I, Jean F. Resvick, do hereby certify that on the 18th day of September, 1968, I found evidence of the Southwest Section corner of Section 29 Township 34 North, Range 15 East, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner:

Description of original monument and accessories and subsequent restorations:

Surveyed in 1859 by James McBride
 80.00 chains North between Sections 31 and 32 set wood post for the corner of Sections 29, 30, 31, 32.
 Hemlock, 10 in., N. 89° W., 44 Lks.
 Birch, 24 in., N. 1° E., 39 Lks.
 Hemlock, 20 in., S. 28° E., 84 Lks.
 Birch, 24 in., S. 18° W., 65 Lks.

Description of corner evidence found:

24 in. yellow birch stump. Set a point N. 18° E., 42.90 feet from the yellow birch found. From point set found:

Hemlock stump, S. 28° E., 55.4 feet
 Birch stump, N. 1° E., 25.7 feet
 Hemlock stump, N. 87° W., 29.04 feet

Description of monument and accessories I established to perpetuate the original location of this corner: from the remains of the original bearing trees found I set a 6 inch diam. concrete monument 4 feet long, 6 inches in diameter concrete monument 4 feet long, 6 inches below the surface of the ground with a brass cap marked:

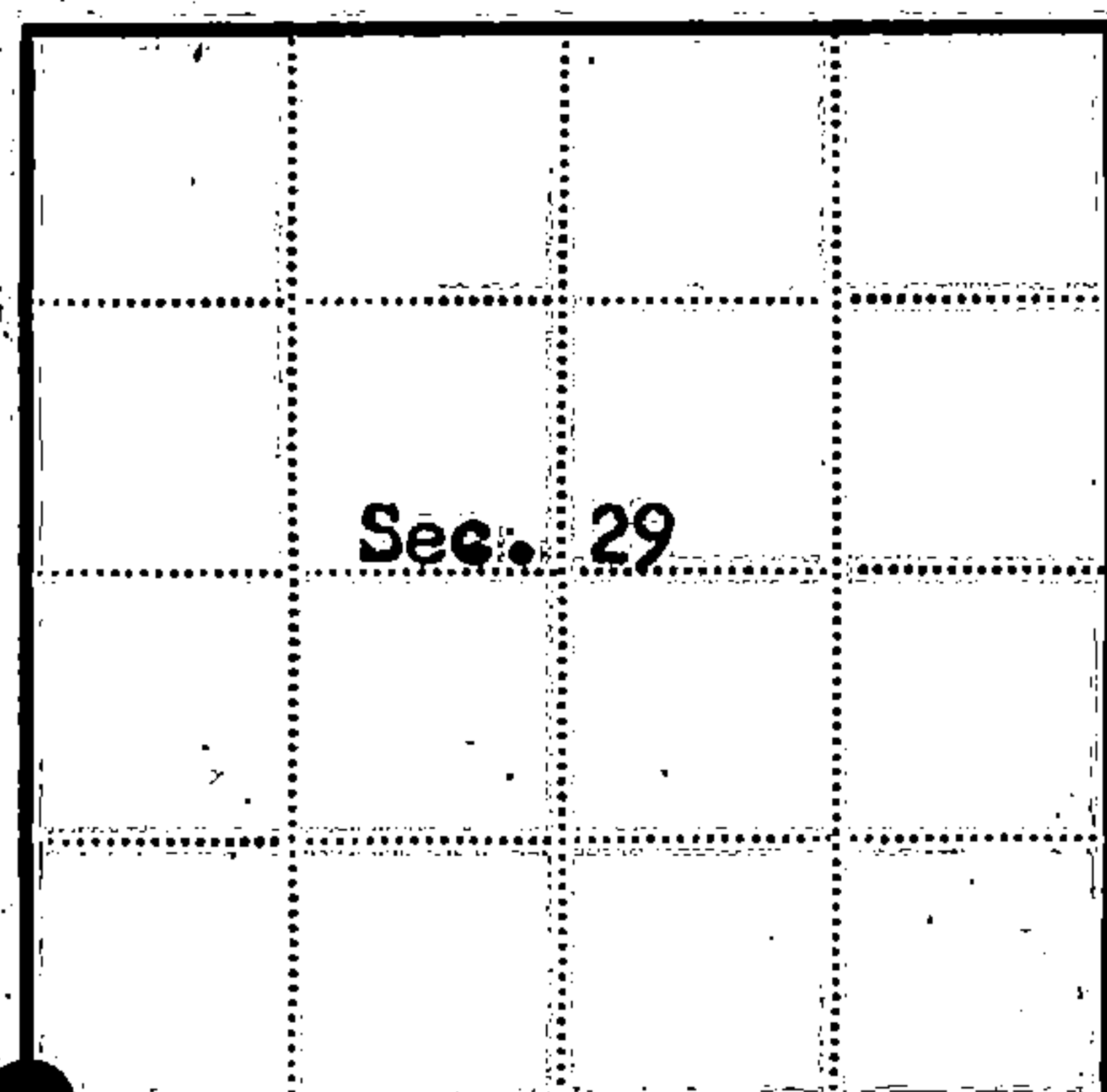
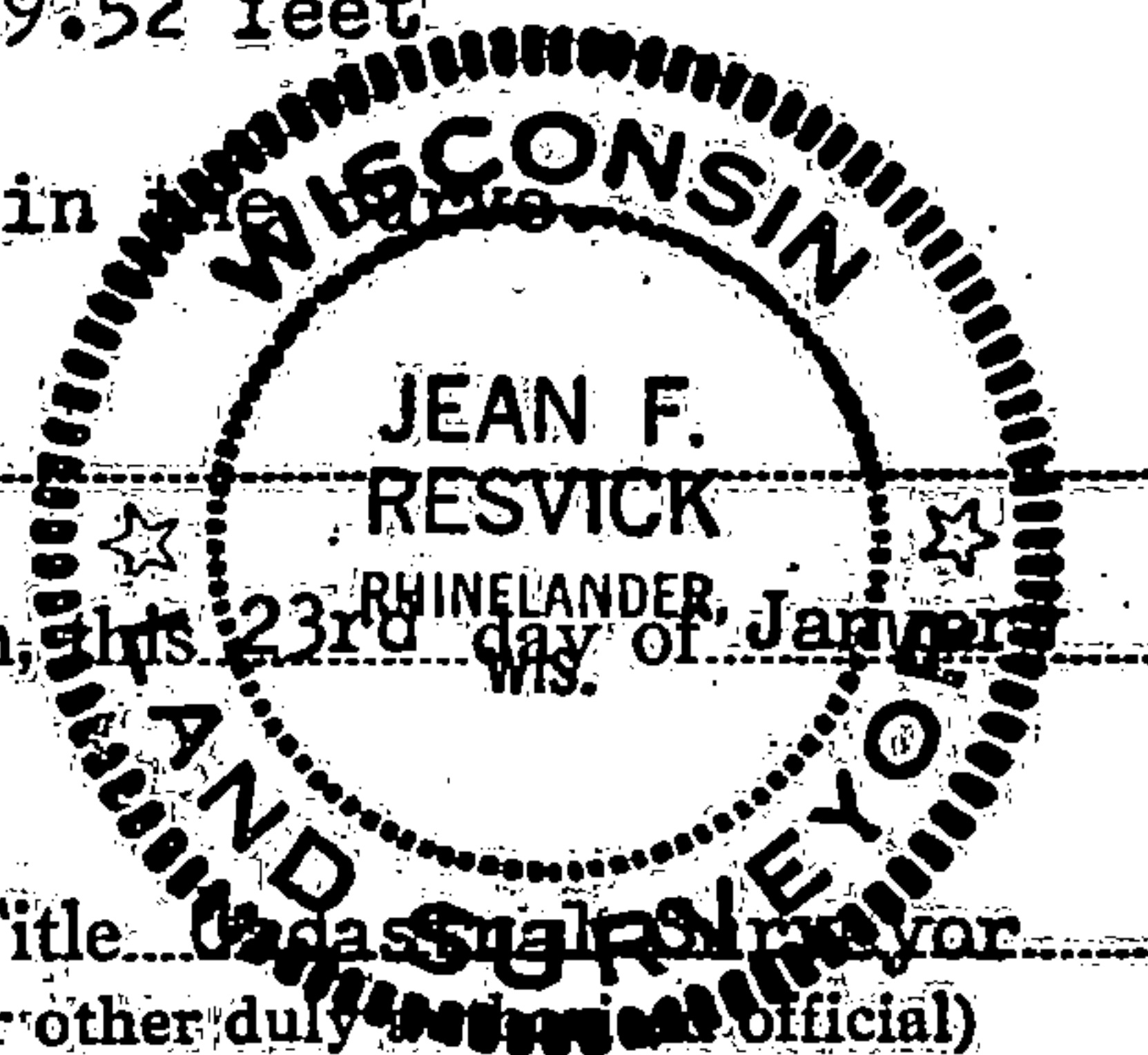
