

December 6, 2024 - Surveyor 3032 - Michael J. Hoffman - indicates this position as "found aluminum capped monument" on county record Map #371631-20241206.

July 28, 2025 - I found a 2.4" diameter aluminum pipe monument with a 3.25" diameter aluminum cap stamped to identify the corner location. The monument is ±100 feet west of a woods road, is in a rock pile and extends ±12" above grade. I also found 3 of Garske's bearing trees alive and in good condition.

I established 1 new reference monument as shown below.






