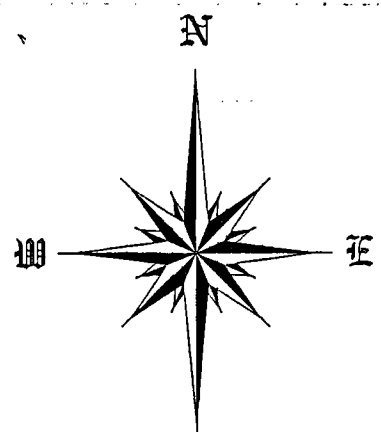

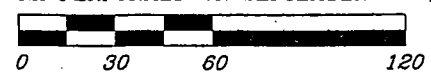
LOCATION / DESCRIPTION

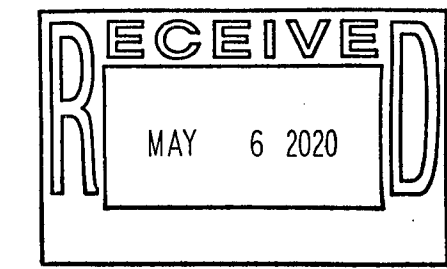
